

Enclosed Trailer Warranty

Dealer Responsibilities

The Stump's Smokers, LLC is responsible for providing you with the warranty information and explaining to you all of the Limited Warranty and claim procedures under the Enclosed Trailer Manufacturer's Warranty. The Purchaser is responsible for submitting any warranty claims you wish to make under the terms of this Limited Warranty.

Required Dealer Warranty Claim Procedure

1. In order to validate your Limited Warranty, the original copy of the Manufacturer's Warranty Card must be signed by the Dealer and the purchaser, and must be postmarked no later than (10) days following the purchase of your trailer. IF THIS SIGNED WARRANTY IS NOT POSTMARKED BY THE TENTH DAY AFTER PURCHASE OF THE TRAILER, ALL EXPRESS WARRANTIES SHALL BE NULL AND VOID.
2. All warranty requests must be submitted by the Purchaser to The Enclosed Trailer Manufacturer in writing or by calling them. All arrangements for repairs must be made and approved by their factory before any repair work is done. The factory will give you written instructions to have your trailer repaired. Repairs will be performed at their factory or a qualified service center depending upon the warranty request.
3. Any defective parts must be sent by prepaid freight to the Enclosed Trailer Manufacturer in order to qualify for the claimant for the manufacturer's replacement under the Limited Warranty. ANY DEFECTIVE PARTS MUST BE RETURNED TO THE MANUFACTURER WITHIN 30 DAYS FROM DATE OF APPROVAL TO QUALIFY FOR REIMBURSEMENT.
4. Stump's Smokers, LLC or the Manufacturer will not reimburse you for any adjustment or repair to your trailer without prior written approval by Stump's Smokers, LLC and the manufacturer.
5. Transportation of any trailer to and/or from the manufacturer or any approved service center shall be the responsibility of the trailer owner. If authorized repair must be done other than at the factory, Stump's Smokers, LLC nor the factory will warrant such repair work or replacement parts.
6. The manufacturer reserves the right to not pay unreasonable costs for replacement or repairs of defects in Manufacturer's enclosed trailer and may, at its discretion, establish a reasonable reimbursement for any authorized work performed under the terms of this Limited Warranty

STUMP'S SMOKERS, LLC MAKES NO EXPRESS OR IMPLIED WARRANTY AND THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE DESCRIPTION ON THE FACE OF THE MANUFACTURER'S WARRANTY CARD.

BE SURE THAT THE HITCH BALL ON ANY TOWING VEHICLE MATCHES THE DIMENSION OF THE TRAILER COUPLER
BE SURE THAT YOU SECURE ALL SAFETY CHAINS AND BREAKAWAY BRAKING SYSTEMS BEFORE EACH USE
BE SURE THAT ALL LUG NUTS ARE TIGHT BEFORE USING
BE SURE TO CLOSE AND SECURE ALL DOORS BEFORE TOWING
